This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023 - Direct Award Process C. For the avoidance of doubt, the provisions of the Procurement Act 2023 do not apply to this award. The publication of this notice marks the start of the standstill period. Representations by providers must be made by midnight 04/04/2025. This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR. An assessment of the current Provider with regard to the weighted key criteria was conducted and it was concluded that the Provider is meeting the required standards with high quality services provided with experienced staff at value. They provide an integrated service within the Trust's and community care system enhancing patient choice and accessibility, while also supporting employment in the local community. The decision to award the contract was made by the General Manager, Community Integrated Care, Family Health Care Group - 21/03/2025 and supported by the Finance Director and Head of Contracting. No conflicts of interest were identified.

This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Procurement Act 2023 do not apply to this award. This contract has now been formally awarded using the PSR Direct Award C process. The contract was formally awarded to the provider on 15th May 2025. The contract is for the period from 01/04/2025 to 31/03/2026 with the option to extend for 2 further 12 month periods. The estimated lifetime value of the contract including the extension option is £630,000.
