The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023 - Direct Award Process C. For the avoidance of doubt, the provisions of the Procurement Act 2023 do not apply to this award. The publication of this notice marks the start of the standstill period. Representations by providers must be made by midnight 04/04/2025. This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR. The contract was formally awarded to the provider on 15th May 2025. The contract is for the period from 01/04/2025 to 31/03/2026 with the option to extend for 2 further 12 month periods. The estimated lifetime value of the contract including the extension option is £630,000.
