Hampshire County Council has awarded an Open Framework under the Light Touch Regime and is now onboarding training delivery partners across all sectors including public, private, voluntary/community organisations and Employer Representative Groups. This Framework remains open for new applications from the date of publishing for the

entire duration of the Framework and is lotted by organisation type.

The framework is to support the Council to be able to quickly respond to grant and other funding opportunities to enable delivery of training to the public and employees of businesses across the entire county of Hampshire, including Portsmouth, Southampton and the Isle of Wight.
