NIE Networks received funding for the EV Managed Charging Innovation project from the Utility Regulator as part of The Green Recovery Scheme following award of the contract. NIE Networks are extending (Lot 1) for a further 12 month period and have increased the value to ensure sufficient funds to cover the EV Managed Charging Innovation project. It is our intention to commence a new procurement exercise in March

2023 to replace the Engineering/Telecommunication Professional Services framework agreement.
