Hampshire County Council invited organisations who provide overnight respite operating in or around the area of Hampshire County Council to tender for the delivery of overnight respite services for children and young people with a disability.

The awarded procurement vehicle is for an initial 2 years with the option to extend for a further 2 years at the Council's discretion. The Council procured this arrangement utilising the Light Touch Regime and its total value is £5,000,000.

Throughout the duration of the procurement vehicle, new providers of overnight respite can apply to join at any time. Providers are required to be Ofsted Registered at 'Good' or above.
