The scope of the framework will give the Authority access to quantitative modelling groups, capability and tools for animal and plant pest and disease modelling and expert analysis to meet ad hoc policy requests. The Authority requires the Contractor to be available to respond to emergency situations in the form of expert consultation and/or input to modelling exercises. The quantitative modelling provides the authority with evidence to support policy making in the event of an outbreak of animal and plant pest or disease and supports policy and operational activity relating to the management of animal and plant pest and disease already present. It also contributes to the evidence base around preparedness for future threats. The purpose of carrying out this analysis is to inform policy decisions which may need to be made quickly, sometimes based on evidence that is not complete.
