Interim caretaker contract for a duration of 12 months with the option to extend for a further 12 months at an estimated contract value of £1,319,212, (including 12 month

extension). There will also be a fixed monthly payment of £4,167 to cover costs associated with service delivery and a one off start-up cost of £40,000 to be paid at the commencement of the contract.

The commissioner is looking for a provider to deliver 1,008 clinical sessions per year.

This is a unique situation in that premises are available which must be utilised by the successful interim caretaker provider.

The current premises are purpose built and fit for purpose and the Commissioner intends to provide a full subsidy for premises costs.
