Evidence included below has shown that a worker with Lived Experience can be seen as visible recovery which is achievable. They can use their shared experience to develop trusting relationships and give effective support, which allows trust to be built alongside services leading to improvements in multiple aspects of life. One of their key functions is to support those people furthest away from entering structured treatment for drugs and alcohol addiction and supporting them into treatment services.
