Due to the age of the structure it's materials, and the aggressive environment, many elements of the structure are deteriorating.

- Widespread corrosion and section loss of the below deck metal elements including the structural girders (both longitudinal and transverse), the bearings, and connecting elements including the rivets.
- Particularly heavy corrosion and section loss to the first cross beam of the moving span, due to water ingress from the adjacent joint. This includes 50% section loss to some stiffeners.
- Damage and deterioration to the timber "Acme" deck panels and sealant to the lifting section carriageway.
- Extensive failure of protective pain system below the deck level, and area failures of same above the deck level.
