The Authority has no allocated revenue or capital budget for the redevelopment of the Site but will provide the selected Economic Operator with a 125 year lease for the Site and will be supportive of applications for grant funding and the like, within existing regulatory and legal frameworks. The stated contract value of £1 million represents the Council's expectation of the minimum level of investment of the Economic Operator on the upgrading and development of the Site, as referenced in Selection Questionnaire Question 5.1.
