- Allow MHTS Administration staff the ability to make layout changes and content changes to the website via the Hybrid Headless Content Management System
- Ensure the website and its associated technical components are built using modern standard, supported technologies
- Ensure the new react front end Member's portal area is secure and meets all current Security and Data Protection Standards.
