A larger and more comprehensive Building Management System is required at Central Headquarters (CHQ), Fleet Workshops/Stores and the Brigade Training and Development Centre (TDC) to replace the current Trend based Building Management System.

The contract will be delivered in 2 phases with two separate (scalable) solutions being requested.
