The current situation is as follows; Belfast's inner-city consists of approximately 58,000 households (estimate 48,000 low-rise; 10,000 apartments) Households are provided with two recycling boxes (55 litres) or a wheelie-box (c.3,000 properties) for dry-recyclables (households have the option as to what material to allocate to which box – paper & cardboard, plastics & tins, or glass) collected weekly by the contractor and a food waste “caddy” collected weekly by the contractor
