This service relates to the provision of a Community Dermatology Service.

The Provision of GM ICB Community Dermatology Services described in this questionnaire and the draft specification, relates to GM ICB's intention to establish a contract agreement for up to 3 years with the possibility of an option to extend, at the Relevant Authority's discretion, for an additional two year with an indicative overall total contract value of up to £27,852,903 for the 3 years of contract and £18,569,806 for the two-year extension, up to a total estimated value of £46,422,709.
