The transition that has been done so far, however, has been hugely successful and as well as improved service and flexibility of service provision – eg during COVID the HB were able to double the telephony capacity over night to deal the increase call volumes and facilitate the establishment of call centres. The Health Board wishes to complete the transition process already started with the existing supplier which has been prohibited due to the COVID pandemic.
