Identified cohorts of children and young people are likely to include those who are unable to attend school for a variety of reasons, for example due to medical needs or permanent exclusion. DCC could be looking to explore a range of short-term alternative education provision as part of this opportunity to best meet needs. For example, tutoring services, education based mentoring services, education-based activities and learning support provided outside a 'typical' classroom setting.
