The service focuses on delivering outcomes which support individuals in reaching their optimum independence and improve the readiness for transition into the most appropriate and cost-effective forms of support as adults. The aim is to reduce the reliance on long term residential care or similar placements and allows individuals to remain with families for longer. This is the only service that provides dedicated short breaks and pathways to independence in the North Somerset area. It is of critical importance to the young people who attend and their families, and in the delivery of statutory functions.
