New Addington Group Practice is a GP practice operating in the South of Croydon as part of the Mayday South Primary Care Network, from one main site at Parkway Health Centre and a branch practice at Fieldway Health Centre, New Addington

The current contractor at each location provides essential and additional GP services and holds an APMS contract with the ICB.
