The contract will be for a minimum duration of 5 years up to a maximum duration of 10 years (subject to external funding being available to the Council); however, it is expected that in the tender response that tenderers will provide a response for each option (5, 7 or 10 years) to enable the council to determine the optimum length of contract that will deliver best value. It is intended that the contract will commence at the beginning of August 2022.
