The Council intends to enter into a further contract with Omnigenix to provide the Services into the commencement of the Golden Valley, Cyber Central redevelopment to ensure continuity of delivery of the Services.

The Services that Omnigenix provide include the following:

- Advise the Council on the requirements and options for a new Cyber Innovation Centre

centred in Cheltenham

- Advise the council on the planning and delivery of a financially viable operational model for the Innovation Centre
- Advise the Council on the creation of a local Cyber cluster that reflects the requirements of the local and regional cyber ecosystem
- Provide stakeholder management within the Cyber and tech industries and advice on stakeholder mapping and strategy
- Facilitate links and advise on various collaboration options with local academic institutions
- Facilitate links with relevant government authorities and advice on the ongoing strategy and tactics
- Create and manage a Cyber Leadership Board to advise the Council

The Contract will be for a fixed 12 months period with an option to extend (at the Council's discretion) for up to a further 12 months.

The initial duration of the Contract is from 1st August 2022 to 31st July 2023, working 2.5 days a month at a daily rate of £785 excluding VAT.

#### **IV.1.1) Type of procedure**

The Council has considered the Services to be provided under the Contract, and does not consider that these Services could be effectively provided by an alternative or substitute consultant. The Council believes that the requirement to use Omnigenix as a consultant (and the fact that there is no alternative provider) arises from technical reasons.

In particular, given Omnigenix' previous involvement in the Cyber Central redevelopment, Omnigenix has specific know-how at its disposal that is relevant and essential to the effective delivery of the Services (that is, Omnigenix' "corporate memory" is the determining factor as to why Omnigenix is the only economic operator capable of performing the Services, and why competition is absent for technical reasons).
