A number of these facilities are in need of replacement bus washing equipment. Translink has 20 bus washer systems, of which 18 are scheduled for replacement over the next 5 years. The objectives of the project are to create a multi-supplier call-off dynamic purchasing system [DPS] for the replacement of bus washes in Translink bus depots. The DPS will relate to removal of existing equipment, supply, installation and commissioning of new equipment.

Precise information on deadline(s) for review procedures:.
