The AMHP course will be for up to 10 students beginning in September 2022, and up to

10 students in September 2023, and must be able to be delivered via a direct delivery model within Hampshire, a virtual model and a blended approach.

The contract value for the initial period cannot be in excess of £110,000. However, subject to funding availability, consideration could be given to a one year or two year extension.

There will be a requirement for close liaison between the course provider, the Learning and Development Team and the AMHP service operational lead to ensure that the course meets all necessary requirements.

The successful supplier will provide as a minimum:

- research materials;
- academic teaching;
- learning materials and course books;
- support for placements;
- oversight for any lecturer practitioners;
- administrative support for students;
- additional learning support for students (if required);
- independent assessment of the learning outcomes;
- quality control of academic standards.
