This will bring together the content of each LAEP, address cross-boundary issues, etc • Actions, priorities and decisions – assessing the pathways to identify interventions and timelines for deployment with: - Diversity/flexibility in different places - Priority project identification - Long-term (opportunities for scale up) • Revising finalised LAEPs to take account of any significant policy, technological or regional/local changes
