The service will ensure that where a person is in receipt of any secondary or specialist mental health services, appropriate levels of communication and joint working are maintained, and that this element is captured within the person's support plan. The Provider will work with Bedford Borough Council, East London Foundation Trust (ELFT) and other partners to develop and implement common agreed practices and processes to ensure a consistent way of working and a reliable delivery of quality services. The service will contribute to the delivery of the Bedford Housing Strategy 2021-2026, Homelessness Strategy, and accommodation strategies, and of aims outlined in the 'Bedford Borough Joint Health and Wellbeing Strategy' as well as in the Bedford Borough Corporate Plan 2022-2026. It will build on lessons learnt from a recent independent Supported Housing Review. The provider must support the aims of the Bedford Borough Housing Allocations Policy April 2021 in enabling people to move on from supported accommodation services. The contract term will be three (3) Years with Option to extend for two (2) years delivered in two (2) twelve (12) month instalments.
