(ii) improve community support for autistic people – by ensuring that consultant psychiatrists working across a range of community specialities, including mental health, children and young people, older adults, and forensic services, are skilled in the recognition and assessment of autism.

(iii) improve support within the criminal and youth justice systems – by ensuring that psychiatrists working in these settings are skilled in the recognition and assessment of autism.
