The programme aims to equip DCSs in their first year in the role with the necessary skills and support needed to be exemplary leaders, whilst simultaneously creating a pipeline of effective future DCSs via the Aspirant strand. The programme will also seek to improve diversity amongst DCSs by recruiting Aspirants from a range of protected characteristics and socio-economic backgrounds, leading to greater DCS diversity as they progress through their careers.
