Chiltern is expecting to separately seek a financier to support the purchase.

Chiltern is assessing its rolling stock strategy and in particular, the supply of rolling stock that can achieve non-diesel operation.

Chiltern is seeking to invite expressions of interest and tenders for the supply of new battery-powered electric rolling stock to operate passenger services. The new rolling stock may be purchased together with selected maintenance services, charging infrastructure and modifications and upgrades to the maintenance locations.

A Supplier Selection Questionnaire will be sent to all parties who register interest to evaluate capability and financial standing with successful applicants proceeding to the Invitation to Negotiate Stage.

Responders should have the technical capability and competency to manufacture, test, certify and maintain electric powered rolling stock.

Interested parties should note Chiltern is undertaking parallel procurement processes relating to the supply of new or re-manufactured battery electrical multiple units with a view to selection of one solution only. Partaking in this procurement process may not result in any contract award and suppliers partake at their own cost and risk.
