The FCDO employs more than 17000 staff in 179 countries. There is a very diverse range of user groups, requiring the flexibility to initiate travel from any location to any destination, including from overseas back to UK or another destination, and may involve flexible tickets, group traveling arrangements, families travelling with dependents, and delegations travelling to international events.

Health and Welfare travel arrangements for officers and dependents (to bring them to the UK or to another designated location for health checks/investigations/treatment)

Coordination of the King's Messenger journeys
