Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The anticipated contract length of this procurement has been extraordinarily impacted by a change in regulations, around conducting of external body reviews, namely around understanding the scope of the framework and review of the framework renewal tender documents. In order to roll-out the renewal framework, an additional 4 months has been applied to conduct a full open procedure tender process.
