Pool Academy is a state funded school for students aged 11 to 16 from the Camborne, Pool and Redruth area of Cornwall. It has a student capacity of 1,050 and currently has 573 on roll with a growth plan which will increase student numbers to 800 over the next 4 years. Pool Academy's core values: Aspiration, Belonging and Respect are at the heart of

everything the school does. Pool Academy has the highest aspirations for all students, mirrored with the very highest expectations, ensuring learning is maximised and students thrive in an environment personalised for them.
