The contract is being extended for 12 months from the 1st April 2022 to the 31 March 2023.

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

The contract is being extended for 12 months for the following reasons:

Uncertainty of funding from external partners and management of potential reduction in budget and resulting redundancy costs.

Evaluation of the delivery of awarded PHE grant proposal and achievement of outcomes to enable good practice and learning to be incorporated into a new service delivery model.

Implications of the findings and recommendations following the Health Secretary commissioned 'Review of Drugs' including possibility of investment in extra funding for substance misuse services. This will be announced as part of the comprehensive spending review.
