The contract is being extended for 12 months from the 1st April 2022 to 31 March 2023. The value of the extension is £499,863

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

The council has agreed to implement a whole system approach to supporting adults with complex needs, which will create a service pathway to which the multiple needs provision must be aligned. The national response to rough sleeping during the pandemic has created further change in local service design; the 'everyone in' initiative, which provided emergency accommodation to rough sleepers, is being continued locally, and integrated into the wider development of a complex needs offer. As this activity is not yet fully implemented, it is not considered prudent to offer contracts to market that will require imminent revision to remain aligned to the wider service offer.
