Explosive workers safety is Dstl's primary concern and the RSDs give data which support the risk assessment for which the explosive workers can perform their work safely. Furthermore, there are specific interoperability and safety requirements that must be fulfilled. Thermal Hazard Technology are the only company to manufacture RSDs that meet these requirements and own the proprietary rights.
