Aylesbury High School is a popular and oversubscribed 11-18 girl's selective school, serving Aylesbury and North Bucks. The school opened in 1959 and became an Academy in 2011.

The school currently has 1307 students on role, with 907 pupils in years 7 - 11 and 400 in the 6th form, along with 130 teaching staff and 80 non-teaching staff,

The tender project is seeking to appoint a Contractor whose initiative and innovation will be welcomed for the provision of service within the existing facilities with a focus on exciting new food concepts to satisfy a wide range of pupil tastes and dietary requirements. The School would wish the successful contractor to review the current range of services offered and make recommendations accordingly.

The contract being tendered is for three years in duration from 1August 2022 to 31 July 2024 with the option to extend for a maximum of a further 2 years at the discretion of the client.
