Linking and connecting wider through networking and events with opportunities to bring in experts with specialist knowledge and learning on areas such as

tackling inequalities

developing partnerships, joint working approaches, etc.

helping build grant holders storytelling capability and developing influencing skills

connecting/hearing from other projects (and Funders) in their local areas addressing health inequalities
