Equipment and adaptations are also installed in schools, care homes and Council managed public buildings such as leisure and community centres. Aids for Daily Living Equipment Supply - The contracted supplier would be required to supply a wide range of Aids for Daily Living such as grab rails, bath seats, hoists, seating and dynamic mattresses etc. to ATEC24 for the aforementioned purposes. It is estimated that 80,000 items of equipment are issued annually.

Aids for Daily Living Equipment Servicing & Maintenance - By law some of the equipment requires to be regularly serviced and maintained. These services will be provided by the contracted supplier who will undertake the servicing and maintenance as instructed by ATEC24. It is estimated that 10,000 items of equipment are serviced/maintained annually.
