We find this achieves some great outcomes for our young people and have seen the benefits of having children matched with engaging support workers.

Support Services

Currently, we use different providers to offer a range of support services to our young people. This is in a variety of different forms. We often rely on support workers to provide; an escort to and from an education provision, or contact. To be stationed in the child's home to offer the carer support and respite, taking children out for activities and mentoring, also helping with any additional care a child may need. We are also seeing an

increase in the number of children who need this support that have additional needs such as Autism, young people struggling with their mental health and those needing support to engage in positive activities to increase their confidence.

We are seeking companies which have experience of successfully delivering any of the above services for vulnerable children and young people, who may also be looked after.
