NHS Arden and Greater East Midlands CSU (AGCSU) is acting as an agent for and on behalf of the Commissioner.

The service commencement date is 1st June 2024 for a contract period of 2 years and 7 months. With the Commissioner having the option to extend for up to a further 2 years (subject to DDICB funding approval for any extension period). Based on the current contract it was anticipated that the service provision resultant of this procurement, will have a maximum contract value available is £1,100,000.00 per annum prorated.
