Forest Operations need to procure a service for 2 years, to support Nematode Application Operations throughout Wales. This operation is part of the NRW Integrated Pest Management strategy of Crop protection, to protect establishing crops from Hylobius weevil damage. The pine weevil *Hylobius abietis* is a common cause of mortality in young conifers used to restock forest sites after clearfelling, the service involves the application of nematodes for the biological control of weevil larvae.
