The intent to award a contract to deliver a Gypsy and Traveller Public Health and Wellbeing Service which aims to improve the health, wellbeing and independence of the Gypsy and Traveller communities in Leeds.

The service will continue to deliver a range of services to support the health and wellbeing of the Gypsy and Traveller community.

The proposed contract falls within the scope of the Provider Selection Regime (PSR). Route C of the PSR will be used to directly award the contract to Leeds GATE. Route C can be applied where 'an existing provider is satisfying the existing contract and is likely to satisfy the new contract, and the proposed contracting arrangements are not changing considerably from the existing contract.'

The total value of the contract will be £420,000.00 and will last for a period of five years with the option to extend for a period of up to 36 months in any combination.

This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations

2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. The publication of this notice marks the start of the standstill period. Representations by providers must be made by 00:00 on 14th September 2024 (The standstill period will end at midnight on the eighth (8th) working day). This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR.

No conflicts of interest were identified as part of this process.

The decision maker (Director of Public Health) is fully in support of this intent to award and believes that services will continue to provide support to the Gypsy and Traveller community.
