The Crisis Services lot is focussed on relapse prevention, assisting Approved Organisations respond to patients including Children and Young People, Adults and Older People at times when their mental health and/or social situation has deteriorated to the point they are at considerable risk and require additional support to remain in their current accommodation and/or prevent further harm.

Services provided under this lot are intended as an alternative to A&E or inpatient psychiatric admission and include, but are not limited to:

- 24/7 telephone helplines
- Crisis Home Treatment Teams (CRHTT)

In addition, for Children and Young People:

- 24/7 assessments and brief response
- Extended hours intervention and community provision
- Extended hours intensive community care
