NHS Cambridgeshire & Peterborough Integrated Care Board intend to award a contract to

Malling Health UK Ltd for the Provision of Primary Medical Services for East Barnwell Health Centre following a robust Most Suitable Provider Process. The contract shall commence on 10 October 2024 and end on 09 October 2034.

This is a 7 year contract (Contract value £7,764,179.12) with the option to extend for a further 3 years (Contract Value: £3,327,505.34). The lifetime contract value is estimated to be £11,091,684.46.

This is an existing service and has been awarded to a new supplier. The initial term of the contract is from the 10 October 2024 to 09 October 2031, there is an optional extension available for up to 36 months.

The contract will be awarded to to Malling Health UK Ltd following a robust Most Suitable Provider Process under the Provider Selection Regime Regulations.

The award criteria is the Most Suitable Provider Process Key Selection Criteria, with a weighting of 100.

The award decision makers are NHS Cambridgeshire & Peterborough Integrated Care Board, the Most Suitable Provider process was approved by Primary Care Commissioning Sub-Committee of the NHS Cambridgeshire & Peterborough Integrated Care Board and Procurement Panel.

No conflicts of interest were flagged as part of this process.

The Key Criteria were weighted as follows;

- Quality & Innovation – 32.50%
- Value – 15.00%
- Integration, Collaboration and Service Sustainability – 22.50%
- Improving Access, Reducing Health Inequalities and Facilitating Choice – 20.00%
- Social Value – 10.00%

The weightings for the 5 key criteria were determined by the procurement panel to give appropriate relative importance to each of the sections equally in line with the commissioning expectations for the service. The key criteria were all deemed to be of equal importance and were used to assess the providers performance accordingly.

Following assessment of the providers against the key criteria above, Malling Health UK Ltd was deemed to be the most suitable provider for this requirement.
