With the Academy's overarching role, they are the preferred partner in providing enhanced independent and neutral assurance for NHS Pathways and 111 Online clinical content, based on their standing and role in the wider clinical community.

With a membership of 24 organisations, and as referred to above, there are no other organisations that could offer the breadth, consistency and formality of service, hence the Programme advocating a Single Tender Award
