The overall purpose of the LMS is to store, process and manage all stock and customer data regarding transactions, membership and ordering; in addition, it integrates with multiple third-party systems such as the authority's finance and card payment system. Additionally, the LMS also manages the Electronic Data Interchange processes for stock from ordering to quotes and receipt confirmation; all of which contributes to the efficient running of the Library Service.
