White in colour, fully customisable flash character, automatic control via adjustable threshold PE cell, and programmable via IR remote or PC. Photometric testing report in accordance with IALA R0203 (E-200-3) and, calculation of intensity and estimation of range would be required plus DDP delivery incoterms to GRAD, Trinity House Buoy Yard, Harwich, Essex, CO12 3JW, UK.
