As part of the passenger screening process, items may be left on a person which require secondary screening. These items can include, but are not limited to, coins and belts. In this scenario, the Department for Transport has advised that Explosive Detection Systems for Cabin Baggage ("EDSCB") equipment or a Small Items X-ray can be used to screen small personal items which may be found on the passenger during the security scanner or body search process. The use of Small Item X-Rays helps to reduce time during the security screening process by enabling passengers to exit the body scanner and process small items without having to process back to divest items into the main EDSCB equipment.
