The Designer Framework will be used to commission design services to deliver homes and mixed use developments, with an estimated construction value of £1.5 billion and a design service value of around £35 million. These targets are indicative and subject to external economic, community and industry influence.

The Framework members will provide design services for RIBA stages 1-3 inclusive, with preference for the lead architect to be appointed by the main contractor for the delivery stages.
