The Buyer proposes to vary the Agreement in order to utilise the option provided for in the Framework Schedule 6 (Order Form Template and Call-Off Schedules) to require additional vouchers for the periods and amounts up to those indicated in the table, as amended. This variation will raise the Total cost/contract value to a maximum of £941,788.80. For the avoidance of doubt, this is made up of the July 2022 Holiday Summer and Full contract period optional extra (£665,372.80) and the additional vouchers, October Half Term 2022 and Full contract period (£276,416) = £941,788.80

Furthermore, the Buyer proposes to vary the Voucher's face value for the Full contract period to include the words "up to" before the amount of £50. This variation will not affect the overall maximum contract value.
