It is only the intention that Corserv will appoint the Framework agreement to the Top 3 suppliers. In the event that the specification type varies in detail from the 3 types quoted in this tender Corserv and its Group of Companies reserve the right to Benchmark any offers received to ensure they are competitive. The tender is intended to create a Framework Agreement whereby Corserv and its Group of companies can order specific anti-vandal type temporary accommodation for Highway Maintenance and Construction projects. The Framework Agreement period will be for 4 years with an anticipated maximum expenditure of £460k over this period, although no actual expenditure is guaranteed by the Corserv Group of companies
