The Authority awarded a contract for this service provision as the requirements were met: to fulfil the specifics of the national I&I process; have an objective to deliver after NHS England has developed a new programme to undertake an investigation and rapid intervention process ("I&I") at a system level for those systems for which we have concerns regarding them meeting their financial plans.
